## **IMPORTANT SUMMER CAMP NOTICE: JUNE 22, 2020**

### **ADDITIONAL OPTIONS. LIMITED SPOTS AVAILABLE. CONTACT THE PAL MAIN OFFICE FOR ADDITIONAL INFORMATION.**

New Jersey Youth Summer Camps are permitted to open effective July 6, 2020. The PAL is excited to offer a summer camp opportunity available to you and your family.

As New Jersey camps open, they are taking on a tremendous responsibility for ensuring the well-being of children in an environment in which the risks are significantly higher and more complex than they were only a few short months ago.

While there are strict guidelines for you to review, the PAL will offer as many activities as possible to include:

- Indoor and outdoor games
- Indoor and outdoor arts and crafts
- S.T.E.A.M. activities
- Remote Control Car activities
- DJ Dance and Music
- Movies
- Gym time
- Outdoor non-contact sports
- Pizza Days
- Ice Cream and Icee days

Additionally, with parent permission, campers will be allowed to bring their electronic and game devices. Specific times during the day will be allotted to “free time” where campers may use their devices, listen to their own music playlist, or read their own book.

The State of New Jersey, through the Department of Children and Families, has mandated a number of guidelines and requirements to support the camp locations and attending families. Please review all of the following COVID-19 Health and Safety Requirements. Until further notice:

1. All camp locations must screen staff and children for fever and other COVID-19 symptoms prior to entry to the program facility each day. Children and staff with a fever in excess of 100.4 degrees Fahrenheit, or exhibiting other symptoms of COVID-19, will not be allowed to enter the facility. Additionally, any person who has been exposed to persons known to have COVID-19 during the preceding 14 days will not be allowed to enter the facility.

2. All camp group assignments will be limited to a maximum of ten children.
3. There will be no interaction between camp groups.
4. Staff will be assigned to, and remain with, only one grouping of children.
5. Sharing of activity supplies, sports equipment and other items will be strictly limited. Children's personal belongings will be kept separate from other campers as much as reasonably possible and will be sent home each day.
6. Close person-to-person contact will be limited.
7. All campers will be required to wear cloth face coverings within the center.
8. Staff shall be required to wear cloth masks while working.
9. Staff will continue to teach and reinforce healthy hygiene practices to prevent the spread of COVID-19.
10. The PAL will implement enhanced cleaning and sanitation practices, to include increasing the frequency of cleaning equipment and surfaces.
11. Since combined group activities are prohibited, shared gym time and playground use will not occur. Classes will be assigned specific play times. Appropriate sanitizing of the area utilized will occur prior to any other classroom use.

Furthermore, the PAL has implemented additional policies and procedures to ensure the health and safety of our children and staff:

1. The designated entry and exit point for the PAL Summer Camp will remain the Southard Center Lanes Mill Road entrance adjacent to the PAL Main Office. PAL security will allow entry to PAL parents/guardians/children only.
2. Only one set of parents/guardians/children will be allowed to enter at a time.
3. Parents/guardians are no longer allowed to proceed farther than the Security Desk or to other center locations.
4. Upon successfully passing the screening process, children will be taken to their appropriate classroom location by assigned PAL staff.
5. Any child who may exhibit any signs or symptoms, or presents a temperature above 100.4 after entering the facility will be immediately removed from their group setting.
6. All parents/guardians must have an appropriate authorized adult available to respond to the PAL on short notice to pick-up any child who may exhibit any signs or symptoms, or presents a temperature above 100.4 after entering the facility.
7. At scheduled end of service, children will again be escorted to parents/guardians at the drop-off/pick-up location.
8. Visitors will not be permitted to enter the center during operating hours, with the exception of emergency or law enforcement personnel in their official capacity, and Department of Children and Families personnel for child protection or childcare licensing purposes.
9. All others, including prospective clients, prospective employees, and third-party therapists or service providers shall be required to schedule an appointment with the PAL Main Office to schedule any potential visits.
