### SECTION 7-14.2 (a) PERMITS

Any person who desires to park a motor vehicle in a municipal lot shall purchase from the Township Clerk community facilities a hang tag permit which shall be hung onto the rear view mirror of each vehicle parked in a municipal parking lot in such a manner as to be clearly visible thereon. An applicant for such a permit may request a duplicate permit for another vehicle which is registered in the same name. Only one duplicate per permit is allowed. A 30 day temporary permit may be issued when a car with a permit is in for repairs.

### SECTION 7-14.2 (b) FEES

The fee for such a permit shall be the sum of **\$200.00 for resident and \$225.00** for non-resident per year termination on December 31 of each year. The Township Clerk is permitted under the terms of this section to adjust a weekly prorated fees charged for such parking permits based upon weekly charges of **\$4.00** commencing on the first Monday in the month of February. This provision shall not empower the Director to issue permits for less than the balance of the year for which the permit is sought. The fee for the issuance of a duplicate permit is **\$7.00** and the fee for the issuance of a replacement permit is **\$5.00**. In the case of a temporary permit to be issued to a permit holder the fee shall be **\$3.00**.

### SECTION 7-14.2 (c) ANNUAL RENEWAL

Persons desiring to purchase a permit hang tag for the next ensuing calendar year may purchase same after December 1<sup>st</sup> of the preceding year.

### SECTION 7-14.3 (b) APPLICATION

At the time of applying for said permit, an applicant shall also present their current New Jersey Motor Vehicle Registration and Insurance Identification Card for EACH vehicle for which a permit and/or duplicate is sought.

### SECTION 7-14.3 (c) NON-TRANSFERABILITY

The permit hang tag to be issued hereunder shall be permanently affixed only to the motor vehicle described in the application, and shall not be transferable.
